- i. Rita Fiedler Fast charging, how can you rely on it? Do you make an appointment?
 - 1. Tesla is installing 8 chargers in one location for their chargers the map in your car will let you know where they are and where you need to charge to make it to your destination and which chargers are available.
 - 2. ODOT will be installing and maintaining additional chargers throughout Oregon in the coming years.

- iii. Janet Bevirt How does the Nissan Leaf compare?
 - 1. For a city car buying a used Leaf is an excellent way to go because some older models don't have a long range.
 - 2. Newer Leaf's models can have a longer range.
 - 3. Leaf doesn't have a cooling and heating system for the battery. In our climate, that doesn't matter much but in Arizona it wouldn't work well.
- iv. Clay Neal Can you provide more info about the environmental costs of making batteries?
 - 1. There is an enormous amount of research into battery chemistry research and recycling.
 - 2. You can use older vehicle batteries for less intensive uses like energy storage.
 - 3. There is one privately owned business in the US that is getting ready to recycle these older batteries.
 - 4. Cobalt is an expensive and environmentally costly material being mined all over the world. There is a lot of research into moving toward a better mining industry for these chemicals.

 - i. Is there any evidence of what caused the wildfire in the McKenzie area?
 - 1. EWEB preemptively turned off service in the area that was impacted, but the investigations are still ongoing because of the complexity of the fire's details.
 - ii. Does any of the work that EWEB is doing go into reducing capacity of the system?
 - No.
 - iii. When EWEB has to dig up an existing portion of the street, does EWEB contract it out?There's a portion of road that was hastily filled in on Lorane Highway from Van Buren to Paige.
 - It is the responsibility of EWEB to repair the road to City standards. Sometimes, EWEB
 will patch the road for temporary work. EWEB has had some contractor quality control
 issues in the recent past. EWEB representatives took the address of the street in
 question in order to take a look at the work.
